ICANN to accept applications for new gTLDs

Cost:

- Application Fee: \$185,000
- Annual Fee: 25 cents per domain / \$25,000 minimum

Types of gTLDs

Unlimited number of gTLDs can be approved

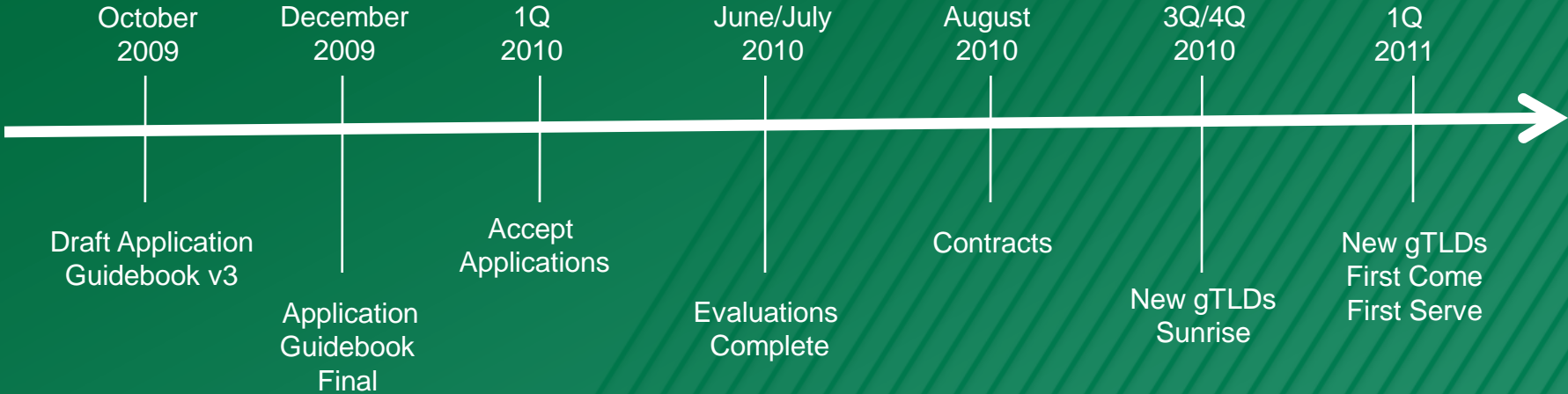

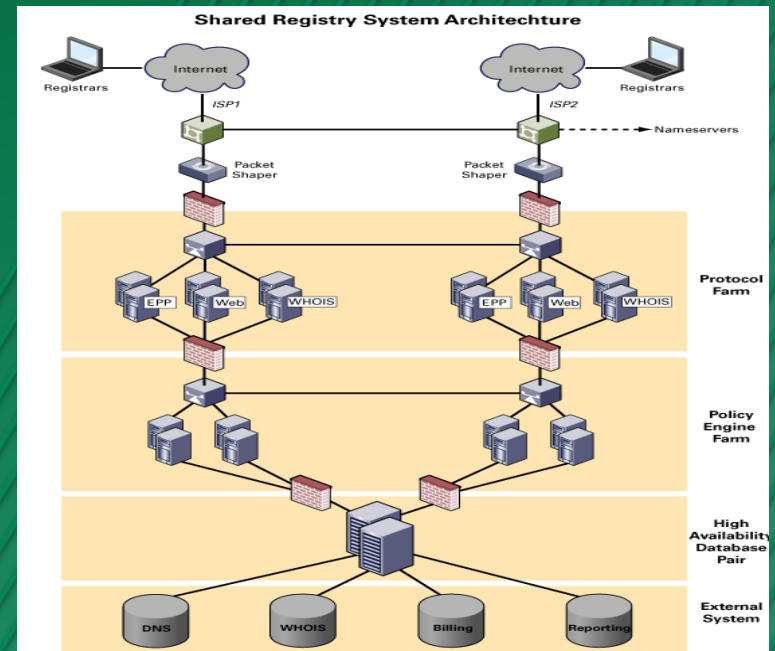
